## (Rich) Compensation for USA Hockey Coaches

Motion: Coaches maintaining a current LTS USA Instructor membership with insurance, background check, SafeSport training, and a current USA Hockey Coaching Certification, and have completed at least one CER appropriate to the age group they are teaching, will be compensated at the rate of \$15/half-hour Learn to Skate lesson instead of \$10/half-hour for LTS USA Instructors.
